The decision from 17th October 2017 The recognition of the foreign diploma for architects

The Minister of Culture,

On the basis of the directive 2005/36/CE of the European Parliament and Council from 7th September 2005 about professional qualification recognition, especially article 46 of this directive;

On the basis of the changed Law no. 77-2 from 3rd January 1977, especially articles 10 and 11 of this Law.

On the basis of the decree no. 2009-1490 from 2nd December 2009 about the recognition of the professional qualifications for performing the profession of architect, especially articles 2 and 8 of this decree;

On the basis of the decision from 17th December 2009 about the modalities of the recognition of professional qualifications for performing the profession of architect;

On the basis of the decisions from 13th December 2016 and 28th August 2017 about the appointment of the National Commission for diploma recognition;

On the basis of the decision from 17th January 2012 changed by the decision from 23rd July 2012 about the recognition of the foreign diploma of architect;

On the basis of the opinion of the commission from 27th September 2017;

On the basis of the request from 17th January 2017 sent by the Faculty, University of Belgrade, Serbia;

Based upon the above listed, the minister has made the following decision:

Article 1

Engineer in Architecture – Master in Architecture diploma issued by the Faculty of Architecture, University of Belgrade, Serbia, is recognised as the equivalent of the French diploma/degree in architecture.

The diploma in architecture from the state university enables its holder to perform the work of a paid architect in France and provides the opportunity to enroll at the training course for "the training of the graduate architect to provide services in person". This training provides the opportunity for its holder to be enrolled in the registry for the exercise of the profession of an independent architect.

The enrollment for the training of "the graduate architect to provide services in person" can be done at the National High School of Architecture ("ENSA"), Special School of Architecture in Paris ("ESA") and National Institute for Applied Sciences in Strasbourg ("INSA").

It is only the diploma of the Engineer in Architecture – Master in Architecture issued by the Faculty of Architecture, University of Belgrade, Serbia, that enables its holder to work as a paid architect.

Article 2

The diploma is recognised for the period of 5 /five/ years, beginning from 2016/2017 academic year.

Article 3

The Director in the area of architecture, the Assistant Director General of the National Heritage, is responsible for the implementation of this decision which will be published in the Official Gazette of the French Republic.

The decision is made on 17th October 2017.
